

## **Delaware & Lehigh National Heritage Corridor**

What has been accomplished?

- ✓ D&L Trail designing of projects in preparation for a busy 2016 construction season!
  - ✓ Work has begun on the North Catasauqua portion of LV Trail Gap #5; Northampton and Catasauqua portions out for bid early 2016
  - ✓ Worked with partners in Walnutport to fund installation of pedestrian crossing and amenities signage to be installed in 2016
  - ✓ Worked with partners to gain permission to jointly sign the D&L and Lehigh River Water Trails
  - ✓ Worked with many partners to apply for multi-modal TIGER grant in Allentown
  - ✓ Currently working with Northampton to make the Nor-Bath to D&L connection. Construction should begin in the spring of 2016 (LV Trail Gap #4)
  - ✓ Worked with various partners to incorporate the D&L Trail into Catasauqua's brownfield revitalization project
  - ✓ With partners, moved several trail construction project forward beyond the LV notably the pedestrian bridge and connectivity projects in Jim Thorpe and the Green Lane project in Bucks County
  - ✓ Explored the use of the Lehigh Canal as a stormwater management tool and means to stabilize the canal and the adjacent trail.
- ✓ D&L Trail Alliance hosted a summer workshop to share best practices for trail pedestrian crossings and to introduce partners to the proposed 9/11 Trail and share trail updates





## **Lehigh Valley Planning Commission**

What has been accomplished?

✓ Livable Landscapes An Open Space Plan for Northampton County – In partnership with Northampton County, the plan was completed, and in November recommended by the LVPC to the County for adoption (adopted by County on January 7, 2016). The purpose of the plan is to guide the conservation, restoration, and enhancement of the County's open space resources and create linkages between natural resources; outdoor recreational facilities; greenways and blueways; farmland; and historic,



cultural and scenic resources. The Plan includes a vision, goals, policies, implementation strategies, and recommendations; existing data mapping and analysis; health, economic and environmental benefits discussion; and county park assessments. The Plan was based on existing LVPC plans (Comprehensive Plan, Greenways Plan, 1LV) and input from a steering committee, key person interviews (county staff, four business owners) and public participation (two rounds of three meetings and a public opinion survey).

✓ Return on Environment Outreach – The project's intent was to promote and provide outreach for the Lehigh Valley Return on Environment (2014) study completed with funding from the HUD Sustainability Communities grant program. Results from the study include natural system services estimated at \$355.5 million each year; total annual avoided healthcare costs and damage to agriculture and buildings estimated to be \$54 million; outdoor

recreation spending and total impact estimated at \$795.7 million annually; and the average premium afforded each home within \( \frac{1}{4} \) mile of protected open space is \$14,600. The project and results were presented to various groups, organizations and the general public throughout the year - Northampton County Open Space Plan Steering Committee, Appalachian Trail meeting, Jacobsburg Environmental Education Center speaker series, PALTA conference, Step Outdoors Lehigh Valley, Lehigh Valley Greenways Festival, Lehigh Valley Planning Awards, Lehigh Valley Watershed Conference, Lehigh Valley Greenways Legislative Breakfast, American Planning Association – PA Chapter Annual Conference, Western Lehigh/East Penn Chamber of Commerce, Northampton EAC, Delaware & Lehigh National Heritage Corridor Half-Marathon, United Way of the Lehigh Valley, Governor's Advisory Board for Community Development. The information was well received at the local and state level, and positive comments from individual audience members demonstrates the success of the project. The project was presented over 7 times (5 additional presentations prior to this grant contract). The LVPC team also participated in 3 different events with signage and factsheets. Each time the information was very well received with overly positive feedback and inquires about the full report. The broad impact of the information makes it very appealing to many different sectors. Overall the project reached over 1,600 people statewide.

## What has been accomplished? (continued)

- ✓ Transportation Alternatives Program (TAP) The TAP provides funding for programs and projects related to bicycle and pedestrian facilities and bicycle education, improvements to public transportation access, the creation of safe routes to schools, the preservation of historic transportation structures, and the creation of trail projects that serve a transportation purpose. The pre-application meeting was held in November for those seeking funding through this PennDOT Program administered by the Lehigh Valley Transportation Study, the Metropolitan Planning Organization for Lehigh and Northampton Counties. The local TAP allocation amount available for the two counties is \$1,271,634; funding is also available through the statewide allocation. The funding will be awarded in April 2016.
- ✓ Northampton County 21<sup>st</sup> Century Open Space Program Reviewed and rated two Natural Areas & Open Space and eight Municipal Park Acquisition and Development applications.

## Penn State Extension – Lehigh & Northampton Counties

## What has been accomplished?

- Conducted a 2015 Master Watershed Steward class in partnership with the Watershed Coalition of the Lehigh Valley, Northampton County Conservation District, Appalachian Mountain Club, Lehigh Gap Nature Center, and Wildlands Conservancy.
  - Training sessions were hosted and taught by LVG partners
  - 18 Master Watershed Stewards were trained and began their group projects
    - Arboretum Planting & Creation of Educational Materials at Lehigh Gap Nature Center
    - Watershed model creation for Lehigh Gap Nature Center
    - Children's pollinator program at Wildlands Conservancy
    - Green roof model for Wildlands Conservancy
    - Stream restoration project with Martins Jacoby Watershed Association
- √ 52 Master Watershed Stewards in the Lehigh Valley reported 1,067 volunteer hours, with an estimated value of \$24,146.21. During this period, they also reported making 1,610 educational contacts with the public.
- √ 138 Master Gardener volunteers in Lehigh & Northampton counties contributed 5,117 volunteer hours in 2015, reaching 15,157 people. They also assisted 16 community groups. The estimated value of their time is \$115,797.71 Master Gardeners promoted stewardship practices by teaching the public about IPM, native plants, habitat, and pollinators.
- Horticulture Department conducted 64 educational events, teaching best management practices to 2,716 green industry professionals and home gardeners.
- √ 3,123 youth from Lehigh and Northampton Counties participated in 4-H
  programs focused on agricultural and environmental education.

## **Watershed Coalition of the Lehigh Valley**

## What has been accomplished?

- Secured funding for and managed the 2015 Master Watershed Steward Program, including program oversight; added several annual program donors.
- ✓ Managed the Master Watershed Steward implementation grant, that included on-the-ground group projects for our 2014 & 2015 Stewards: park signage, rain gardens, and stream restoration projects.
- Carried out strategic planning and development for the statewide Master Watershed Steward program.
- ✓ Worked with project partners to create a standard Master Watershed Steward curriculum and test, and include greater agency representation in the program steering committee.
- ✓ Organized and put on the 2015 Lehigh Valley Watershed Conference, which showcased 19 talks on a wide variety of water resource issues. The conference included a student networking session, to connect college students with area environmental resource employers.
- ✓ Worked with the Pennsylvania Sea Grant to put on an aquatic invasive species presentation for the public.
- ✓ Provided ongoing input for implementation of watershed implementation plans and Rivers Conservation Management Plans.
- ✓ Coordinated conservation and restoration activities between watershed organizations in the Lehigh Valley.

Freshwater Ecology

- ✓ Train 2016 Master Watershed Steward Class
- ✓ Host 5 educational presentations on water resource topics.
- ✓ Develop several table-top displays on the Master Watershed Steward program for use by Stewards presenting at public events.

## Martins Jacoby Watershed Association 2015 Accomplishments

- 1. The planting of the Atlas Dam site over thirty volunteers from the Wildlands Conservancy, Hokendauqua Chapter of Trout Unlimited, Watershed Coalition of the Lehigh Valley's Master Watrershed Stewards Program, and PADCNR joined the MJWA on May 2nd. Four photos attached.
- 2. MJWA and Wildlands Conservancy combine forces to take on a 4000 foot stream restoration on the Oughoughton Creek in Lower Mount Bethel Township.
- 3. MJWA secures \$5,500 grant to promote the 2015 Delaware River Sojourn from the National Park Service. A portion of the grant provided funding for school groups to join the sojourn. Several photos will be attached to a second e-mail.















### **Lehigh Gap Nature Center**

- 1. Completed 13 new gardens in the Landscaping for Communities and Wildlife program plus planted 10 more front yards in Allentown with native perennials; hosted 5 educational workshops (one each at Easton, Bethlehem, and Allentown library plus Moravian Historical Society and Project Easton)
- 2. Expanded Color of Nature program, which included the following in 2015: bilingual bird walks in Allentown's parks, second Conservation Leadership Academy (with Jacobsburg EEC), Allentown Summer School programs, Allentown Parks programs (with Wildlands Conservancy), after school programs at Roberto Clemente Charter and Elementary Charter Schools, one-week residential internships at LGNC for each Color of Nature Leader
- 3. 5,000 students served with environmental education programs, mostly outdoor field trips
- 4. Continued Leadership role in Kittatinny Coalition to help conserve the Kittatinny Ridge
- 5. Hosted National Trails Day and Migration Fest events with support from D&L National Heritage Corridor and D&L Regional Trail Council





#### List at least 2 goals for 2016:

- 1. Continue Landscaping for Communities and Wildlife Program and expand to include workshops for educators/schools
- 2. Continue Color of Nature program, including Conservation Leadership Academy, after school clubs, summer school and parks programs, bilingual bird walks (expanding to Northampton County), expanding residential internships to two weeks, and supplying programing at Beltzville State Park.

TNC received a DCNR grant to match a Northampton County grant to purchase a conservation easement on the Transue Property, Upper Mount Bethel Fens, Upper Mount Bethel Township. This project is underway. TNC, along with several conservation partners, received a state-wide DCNR grant to do outreach to priority landowners along the Kittatinny Ridge, including, of course, Northampton and Lehigh Counties. We hosted two public programs: a daytime salamander hike and a night-time salamander talk, held at Totts Gap Arts Institute, followed an outdoor excursion to the vernal pools.





## **Northampton County Open Space Program**

## 2015 Government Conservation Leadership Award -

Northampton County was awarded the 2015 Government Conservation Leadership Award by the Pennsylvania Land Trust Association.



## 21st Century Open Space Initiative Grants -

14 municipal park grant projects have been approved for 2015; nearly \$3 million dollars have been provided to local municipalities since 2013, totaling 43 projects in 22 of 38 municipalities. Northampton County granted \$300,000 for the preservation of 1,477 within the Kittatinny Ridge and Cherry Valley National Wildlife Refuge; the project will total 4,600 acres within Northampton and Monroe Counties.

## **Trails**

In 2015, prioritization was given to the identified trail gaps within the County. Three major gaps were funded for engineering, design and/or construction (D&L Trail, Nor-Bath / D&L Trail connection and Two Rivers Trail Gap 9A). In September, Northampton County and partners hosted the 9/11 National Memorial Trail ride over a 2-day period. Races, art galleries and educational programming were held along trails located within the County.

#### Livable Landscapes -

The Livable Landscapes report, Northampton County Open Space Plan was finalized in late 2015 and adopted on January 7, 2016 by County Council. The plan outlines goals and



recommendations for land preservation, trails, greenways/blueways, farmland, cultural & heritage areas and recreation/parks.

#### Scenic, Wild Delaware River -

Northampton County is one of nine counties located around the Delaware River to participate in a Geotourism project through National Geographic. Focusing on geotourists, the website and material is concentrated on local businesses, events, recreation and natural areas.





## What has been accomplished?

## Upper Mt. Bethel Township 2016 Accomplishments

This year several projects came together at the 90 acre UMBT Community Park.

The natural area playground for younger children was completed. Besides swings, slides, benches, merry-go-round, a pollinator garden and other playground apparatus, the major feature is a mounded grassy hill with large boulders for climbing.

A large parking area was constructed including stormwater structures and rain gardens.

The Landscaping for Communities and Wildlife grant for native plantings and signage was a big success incorporating many volunteer hours to plant and maintain the new plantings of trees, shrubs and perennials. UMBT EAC funded plant identification markers for each plant group or tree.

A LVG grant supported construction of an observation deck overlooking the wooded wetland and installation of a portion of the nature trail from the entrance road past the plantings and observation deck to the parking area near the barn and playground.

The township has increased Open Space by 25 acres bringing the total to 272 during the duration of the program. There are currently 1437 farm acres protected, with another 60 coming to close.

The township has begun trail development with ¼ mile trail at the park.

Nine trees were planted at the park.





Future projects include planting 30-40 Linden trees and installing a post and rail fence along Potomac Street. A formal entrance with signage and more of the trail system are in the 2016 planning phase.
